Annual Open House and One Frame Exhibit Night PSLC Members

Come join us for a night of several exhibits and short presentations by members positing some of their best research and collecting in a wide scope of stamps, covers, ephemera, and more. Len Kasper and Fred Sargent are promoting the event to the Lancaster Community and to the residents at Landis Homes, and Len is providing special snacks for the event. There may be an auction or two to go along with our usual cornucopia of a bourse, door prizes, and give-away items. No one should go away empty-handed. And as always you will be sent the menu from the Own Hill Bistro should you desire a great dinner ahead of the meeting with your collecting friends. If there are any of you who may still have a question or two on the exhibit part of this evening's events, please contact Paul Petersen. Below are some useful instructions that Paul emailed to everyone at the end of October:

While PSLC calls its exhibit program "One-Page Exhibit Night," it is really "One or More Pages.." Members will put up their exhibit (one or more) on the wall. One goal is to get members to make up interesting exhibits, preferably but not necessarily to stand alone without verbal description. Exhibitors will have the opportunity to discuss their posted exhibits so that members can view the originals on the wall, as well as having their pages exhibited on the big screen. When we know more of each other's collecting interests, it becomes much easier to share (buy, sell, trade, or give) items and interests.

Remember, there are no rules for these exhibits on the 13th. That aside, for those interested, the formal and competitive aspect of one page exhibits follows for your information, as taught by Dick Osman. These rules are not required for our exhibition night. Here goes...

...A one page exhibit should tell a story and contain at least three different philatelic elements on the page. An element can be a stamp, postal card, cover, label, specific or auxiliary marking, and on and on. You want to tell a story by including both philatelic items and text. It can be a story of the philatelic items themselves or the story about a theme or topic using the items to illustrate the story. It is wide open.

Try to have at least three (3) different elements in your exhibit. Cinderellas and other related ephemera are also welcome. Philatelic elements include definitives & commemoratives, coils, revenues, joint issues, encased postage, souvenir sheets, plate blocks, postal stationary, errors, forgeries, covers, air mail etiquettes, cancellations, auxiliary markings, and almost everything else. Because these exhibits won't be judged, feel free to add related ephemera such as maps, letters, labels, and the kitchen sink as needed-as long as it fits on the page or pages.

Online Examples: On the link below are the exhibits of the 2023 One Page Online Exhibition by the American Topical Association (ATA). You'll see that ATA has few rules and no judging. The link below will take you to the 2023 "My One Page Exhibit" page. This event has gained traction and grown every year, and I will continue to send out the notices of the event to you as I receive them. Here you'll see examples of other collectors' exhibits organized by category. As you'll observe, they range from complex to low key in composition. Some have many elements, while others may have only stamps. It doesn't matter if it tells a story.

The ATA program has been active for several years, and a perusal of these web pages may be helpful to give you ideas of formatting and more. Note also that several PSLC members participated in this 2023 online exhibit. One does not have to be an ATA member to participate. I circulated this link earlier in the year, but it is worth another look.

Text is very important in telling the story. Text may be hand printed in fine black ink or done on a computer or typewritten. Weave your text in and around your elements. Fill the page, but don't let it get crowded. If it is crowded, remove the text and/or item(s) that least contribute(s) to your story or create a second (or more) page(s).

Plan: Hard Copy-When you come to the meeting, your exhibit(s) will be taped to the wall, and other members will have the opportunity to view the originals of what you post. You'll be able to take a few minutes to discuss your exhibit(s) including the items, subject matter, and/or the process of preparing it.

The **paper size** for your exhibit proper should be the standard 8.5"x11", and these may be placed in plastic document holders, but they don't necessarily have to. The green tape used to attach your pages to the wall is removable, so there should be no damage to your original exhibit(s). Some exhibitors find that using paper a little thicker than the standard copy paper works better.

Digital submission-You may also send a PDF of your exhibit(s) to Dr. DiComo (<u>charlesdicomo@gmail.com</u>), and these will be projected on the big screen and you can talk about your images. You will have to email your PowerPoint to him in advance, as his laptop does not take a flash drive.

The Elusive Double Transfer on the Ives & Judd Match Company U.S. Private Die Proprietary One Cent Revenue Stamp RO120dt 27 November 2024

THE PRECANCELED BATTLESHIP REPORT

"The Chattanooga Medicine Co." Submitted by Stanley E. Jones Brandywine Valley Stamp Club




Figure 1. A postcard featuring The Chattanooga Medicine Company manufacturing facility located at the base of Lookout Mountain on the shore of the Tennessee River. This postcard is being offered by several EBAY dealers.

The Chattanooga Medicine Co., Chattanooga, TN., was established in 1879. The company has a rich history that is carefully documented by Charles David Head [1]. The company had a modest beginning on a muddy street in downtown Chattanooga. Later, an impressive factory was built at the foot of Lookout Mountain on the shore of the Tennessee River (Figure 1) to support the demand for its products. Head's paper [1] details the founding of the company and follows its successful emergence from the nineteenth century as a competitive manufacturing and marketing force in the twentieth century. This paper also discusses the signature products that the company offered and the successful marketing strategies that it employed for these products.

According to Chappell and Joyce [2], the company employed only one precancel type on 5/8-cent and 2 ½-cent Proprietary Battleship Revenues, RB 23 and RB 28. These precancels occur in red, black and dark blue ink. My collection only includes red precancels on 5/8-cent proprietary Battleships, Figure 2, and dark blue and black precancels on 2 ½-cent proprietary Battleships, Figures 3 and 4. It is often difficult to distinguish between the dark blue and black

inks that were used for the cancels. However, there appear to be at least two dark blue cancels in Figures 3 and 4.

The products offered by the company include "McElree's Wine of Cardui" (Wine for Women), Figures 1 and 5, and "Black Draught," Figure 6. Wine of Cardui was aptly named as it was reported to have a high alcoholic content, reputed to be around 19%. The product was very popular and marketed to women for relief from menstrual disturbances. It is also described as "a harmless bitter wine." With an alcoholic content that was this high, it is surprising that the product could pass the standards imposed by the Pure Food and Drug Act of 1906. I can find no reference as to when this elixir was discontinued, but it does not appear to be presently offered. Its alcoholic content may have led to its demise. However, "Black Draught" (Figure 6), with properties similar to Castor Oil, the other successful product offered by the company, continues to be offered today, (Figure 7).

The Chattanooga Medicine Co. was very active during World War II as the major supplier of ammonia and K-Rations to our troops. After the war, the company demonstrated its versatility by expanding its product line to include several new items: Pamprin, Flex-All, pHisoderm, and Norwich Aspirin. The company continues to prosper today under the name of Chattem, Inc. Head [1] points out in his article that the Chattanooga Medicine Co. was one of the first to recognize the value of outdoor advertising. Head [1] also reports that the company even made deals with farmers to replace the roofs on barns or sheds in exchange for painting advertising on the sides of these buildings. Some of this advertising survives today, a tribute to the success of this scheme for marketing a product.

When the stamps in Figures 1-3 were purchased years ago from a dealer in Chattanooga, I also bought two collateral pieces with them, Figures 8 and 9. These collateral pieces are a cover, mailed in 1900 (Figure 8) to McClellan Bros. in Red Boiling Springs, TN, and the bill for a shipment of Medicinal Products (Figure 9), which was carried by the cover. These are very interesting collectibles that reflect our changing times.

The stamps pictured in Figures 2-4 are the only Chattanooga Medicine Co. precancels that I have seen in over seven decades of collecting. They must be scarce because my collection of precancels on Battleship Proprietary Stamps numbers in the thousands and I have been collecting since 1948. Yet, these are the only stamps used by this company that I have ever found or have been offered to me.

October Philatelic Gathering


The Philatelic Gathering met October 19, 2024 at the Chester County History Center for two stellar lectures. **Bob Myers** showed spectacular material from his exhibit of "Siege of Paris 1870-71: Movement of Mail." The exhibit tells the story of the balloon mail and other aspects during the four month siege. He also showed some new items that will be added to the display. Bob has material from all 54 balloon flights that carried mail as well as some that carried "entrusted" letters handed directly to the pilot. In addition to the balloons, he displayed letters that had been enclosed in lightweight metal balls and placed in the Seine to be carried by the river flow.

The second speaker, **John Howker**, described the Adams Air Mail Pick-Up and Delivery Service introduced in the United States for handling mail in communities that had no airports. The device that enabled the service was developed by the inventor (and dentist!) Lytle S. Adams. The first successful demonstration of the service occurred in 1929 with mail from Youngstown, Ohio to Cleveland. John showed many examples of covers carried by the service and souvenir mail associated with it.


The process was featured at the 1933 Century of Progress World's Fair in Chicago. The system was simplified in 1937. Richard Chichester du Pont provided business expertise and overhauled the procedure. The business became the All-American Aviation company and served 121 communities in six states during the 1940s. The system began losing money in the late 40s and was discontinued. The firm was acquired by Allegheny Airlines and evolved eventually into US Airlines

Dr. DiComo will be ending this year's Philatelic Gathering session with a lecture entitled: *"From the U.S. to Farther India & Back Again. 

began, but Mumm & Co. has become one of the largest exporters of sparkling wines in the world. There does not appear to be any evidence of fiscal activity during the Civil War (G.L. Toppan, H.E. Deats and A. Holland [1]), so it is safe to say that its export business to the U.S. began sometime after the Civil War Revenue Tax was repealed in

Here's a brief story of a USPOD Draft Bank Check, dated Feb. 19, 1851, signed by then PMG Nathan K. Hall (Mar. 28, 1810 – Mar. 2, 1874).

Hall served as Fillmore's PMG from 1850-1852, when President appointed him U.S. District Judge for Western District of NY, an office he held until his death in Buffalo on Mar. 2, 1874.

I truly enjoy the search for U.S. Post Office-related artifacts not often seen by philatelists and postal historians. The draft check illustrated fits the bill. Shown is a U.S. Post Office Department check dated February 19, 1851 and signed by Postmaster General Na-

On October 28, 2024, PSLC President Dr. Charles J. DiComo was a guest lecturer at the Houston Philatelic Society monthly Zoom meeting, where he spoke on <u>"Banking in the Village of</u> Pawling, New York and Surrounding Townships as told through Postal History, Bank Checks, Currency, Revenue Stamps and Postal Cards: 1849–1929". Dr. DiComo lived in Pawling, New York for a decade with his family, and began researching the history of village, town, hamlets and neighborhoods in Dutchess County. He began collecting its postal history, along with real photo

postcards, postal cards, postal stationery, Victorian trade cards, railroad tickets, newspapers, hotel paraphernalia, etc. He shared a sub-collection from this study which included Bank Checks, Promissory Notes, Bank Tags, Fractional & Federal Currency, Revenue-stamped documents and other Ephemera. 

A Five Month Journey of a Baptist Missionary Cover in 1856-1857

The Challenge: Determining the Rates and Routes

The Philatelic Gathering

Saturday, November 23, 2024 at the Chester County Historical Society

At the final Philatelic Gathering of 2024, Dr. Charlies DiComo will present his presentation "From the U.S. to Farther India & Back Again. A Five Month Journey of a Baptist Missionary Cover in 1856-1857. The Challenge: Determining the Rates and Routes".

Dr. DiComo will share an 1856 Postal History Detective Story of an 1856 cover with 20+ cancellations and manuscript markings. The challenge was to determine the journey this cover took from Warren, Ohio to Farther India (Burma) and back again, arriving at the Baptist Mission in Boston after 5 months.

Charles will reveal the cancels, follow the routes and rates and decipher the transit, as well as share the human story of the Reverend Alfred Satterlee, his wife and newborn daughter.

All this was accomplished using numerous resources: personal philatelic references; online databases, philatelic auction catalogs; digital manipulation software; and by contacting colleagues.
